6 & UNDER AND 8 & UNDER DISTRICT TOURNAMENT
MAY 16, 17, and 18, 2008
General Information and Playing Rules

The 6 & Under and 8 & Under District Tournament will be played as per 2008 Texas State Pixie Rules with the following exceptions and/or explanations:

1. After 1 pool game, the tournament will be double elimination.
2. Game Time is forfeit time. Any forfeit might disqualify a team from further tournament Play.
3. All teams must be ready to play at 5:30 PM on Friday, May 16, 2008. NOTE: Depending on the number of teams, we may be required to start on Thursday night at 5:30 p.m. in order to give the 3-game guarantee.
4. All games in the double elimination tournament will be 5 innings or 1 hour, whichever occurs first.
The Pool game for each team will be 1 hour or 5 innings, whichever occurs first.
5. Line-ups must be submitted 15 minutes before game time WITH THE FIRST AND LAST NAMES, SHIRT NUMBERS, DEFENSIVE POSITIONS, ALONG WITH ALL SUBSTITUTES' FIRST AND LAST NAMES AND SHIRT NUMBERS.
6. Home team will be decided by a coin flip which will take place at least 15 minutes prior to game time.
7. No infield practice will be allowed at any time.
8. Uniforms - According to the 2008 Texas Pixie rules and ASA.
9. Any ejected Manager, player or spectator must leave the park area. The Tournament Committee will determine if Manager, player or spectator may return for any subsequent Game.
10. Safety Rule: All according to the 2008 ASA Code, which includes jewelry.
11. Game Suspension: If a game is suspended for any reason, it shall be resumed from the point of suspension.
12. Protests must be according to the 2008 ASA Code. The protest committee will halt play; make a ruling; and then, play will continue, if applicable.
13. The Tournament Director reserves the right to switch teams to a different field -- for the purpose of saving time if behind schedule.
14. THE CONSUMPTION OF ALCOHOL ON ALL PARK/CITY PROPERTY IS STRICTLY PROHIBITED.
15. Any question or situation arising that needs a decision shall be handled by the Tournament Committee.
