- Opening Ceremony:** Friday at 3:00 pm at Pearson Park, Alvin Texas.
All Teams must attend
- Opening Games:** All teams should be prepared to play Friday, 6/15/12, at 4:30 pm
- Awards:** 1st – 4th team awards
1st – 4th individual awards
- Balls:** Furnished by Hosting Association.
- Uniforms:** Must be alike in color, pants and shorts can be mixed but be alike in color. Exposed sliding pants and under shirts must be same color. No plastic visors or bandanas. All caps and visors must be worn correctly.
- Game Time:** Scheduled game time is forfeit time.
- Format:** 3 Game Guarantee – 1 Pool & Double Elimination Bracket Play
- Rules:** As per current Texas ASA Rules
- Time Limit:** All bracket games will be 1 hour and 20 minutes (1:20); pool Games will be 60 minutes finish the batter
- Run Rule:** As per current Texas ASA Rules
- Tie-Breaker:** International tie-breaker rules will be used as per ASA Code.
- Line-ups:** Line-ups are to be turned in to the Official Scorekeeper 15 minutes prior to game time on the official line-up card provided.
- Home Team:** Will be decided by coin flip.
- Protests:** Will be settled on the spot and before the next pitch. They must comply with current Texas ASA Rules. Umpire judgment is not grounds for protest.
- Infield Practice:** Not allowed on game fields.
- Continuation of Play:** All measures will be taken to ensure the completion of the tournament. It is the manager's responsibility to make sure they are aware of any changes in the original bracket. In the event the tournament cannot be completed, **Article 206** in the ASA Code will determine the order of finish.
