10 & UNDER DISTRICT TOURNAMENT
Playing Rules and Regulations
June 8, 9, & 10, 2012

The 10 & Under District Tournament will be played according to the 2012 ASA Code and Texas ASA Guidelines with the following exceptions and/or explanations:

1. After 1 pool game, the tournament will be Double Elimination.
2. Game time is forfeit time. Any forfeit might disqualify a team from further tournament play.
3. All teams must be ready to play at 5:30 PM on Friday, June 10, 2012.
4. All games in the Double Elimination Tournament will be 7 innings or 1 hour, 10 minutes, whichever occurs first.
The Pool game for each team will be 1 hour or 7 innings, whichever occurs first; games can end in a Tie; finish the batter.
5. The run-ahead rule will be according to 2012 ASA Official Rules.
6. Line-ups must be submitted 15 minutes before game time WITH FIRST AND LAST NAMES, SHIRT NUMBERS, AND DEFENSIVE POSITIONS, ALONG WITH ALL SUBSTITUTES' FIRST AND LAST NAMES AND SHIRT NUMBERS.
7. Home team will be decided by a coin flip which will take place at least 15 minutes prior to game time.
8. No infield practice will be allowed at any time.
9. Uniforms - According to the 2012 ASA Code.
10. The Tournament Committee will decide whether an ejected player, manager, and/or spectator may return for the remainder of the tournament.
11. Safety Rule: All according to the 2012 ASA Code, which includes jewelry.
12. Game Suspension: If a game is suspended for any reason, it shall be resumed from the point of Suspension.
13. Protests must be according to the 2012 ASA Code. The protest committee will halt play; make a ruling; and, then, play will continue, if applicable.
14. The Tournament Director reserves the right to switch teams to a different field - for the purpose of saving time if the tournament is running behind schedule.
15. THE CONSUMPTION OF ALCOHOL ON ALL PARK/CITY PROPERTY IS STRICTLY PROHIBITED.
16. Any question or situation arising that needs a decision shall be handled by the Tournament Committee.
