GENERAL INFORMATION SHEET

1. The tournament will be Double Elimination with all play governed by the 2012 ASA Official Rules and Texas ASA Pixie Rules.
2. All teams must be prepared to play by 5:00 p.m. on Friday, June 1, 2012.
3. Posted game time is forfeit time.
4. All games will be seven (7) innings or 55 minute time limit, whichever occurs first. At the end of time or innings if a game is tied, the ITB will be used until a winner is determined.
5. The 6 run per each half inning will be in effect in all games.
6. Texas ASA and the tournament host will furnish the game balls.
7. Protests must be according to ASA Rules for 2012. The protest committee will render a ruling before play resumes.
8. No infield practice will be allowed at any time on the game fields.
9. Home team will be decided by flip of coin.
10. Team at the top of the bracket will take the 3rd base dugout; the team at the bottom of each bracket will take the first base dugout.
11. A suspended game will be resumed from the point of suspension.
12. Alcohol is not permitted anywhere in the complex.
13. Full concessions will be available at all fields. Ice, water and cups will be furnished in all dugouts. A team may bring in an ice chest containing ice and water for towels to be able to cool down players and coaches.
14. The tournament director reserves the right to switch teams to a different field for the purpose of saving time if behind in the schedule or for any other circumstances that might arise.
